



WHAT IS THE VOLUNTEER REGISTRY & LEGAL SPEAKERS BUREAU?

The CBABC Volunteer Registry connects lawyers, who are interested in volunteering their services, with charitable organizations and individuals in need of legal expertise as well as partners with the People's Law School and other organizations in the Legal Speakers Bureau.

HOW DOES IT WORK?

Charitable organizations and agencies send the BC Branch information as to the kind of legal assistance they require. A request for legal assistance is compared to the Registry of volunteer lawyers and, if possible, a match is made. We then match the organization or agency with the appropriate lawyer. Further contact is left to the lawyer's discretion.
