Dear Prime Minister:

Re: Support for LGBTI2S Rights Globally

I am writing to you on behalf of the Canadian Bar Association Sexual Orientation and Gender Identity Community Section (the CBA Section) to commend your government's work in protecting the rights of lesbian, gay, bisexual, transgendered, intersex and two-spirited (LGBTI2S) people around the world, and to urge you to demonstrate Canada's leadership in this field at the upcoming global conference, *Leaving No One Behind: the Equal Rights Coalition Global Conference on LGBTI Human Rights and Inclusive Development* (the ERC Global Conference), to be hosted by Canada in Vancouver August 5-7, 2018.

The CBA is a national association of 36,000 members, including lawyers, notaries, academics and students across Canada, with a mandate to seek improvements in the law and the administration of justice. The CBA Section represents LGBTI2S members in the CBA, and provides a forum for the exchange of information, ideas and action on legal issues relating to sexual orientation and gender identity.

The CBA has actively worked with the federal government in its efforts to uphold LGBTI2S rights in Canada and globally. Earlier this year the CBA adopted a resolution urging the government to strengthen dialogue to obtain timely information and advice on the protection of LGBTI2S people,

to denounce human rights violations against LGBTI2S people wherever they occur, to encourage thorough and impartial investigations into allegations of human rights abuses against LGBTI2S people globally, and to facilitate asylum in Canada for LGBTI2S individuals fleeing persecution.² We are committed to working with your government to advance these goals.

The ERC Global Conference presents a unique opportunity for Canada to demonstrate strong leadership among a global network of stakeholders and to articulate its commitment to advancing LGBTI2S rights domestically and internationally. We encourage you and your colleagues to take full advantage of this opportunity and look forward to seeing the positive outcomes of the conference.

We would be very pleased to meet with you and your colleagues to discuss how we may best support your efforts, at your convenience.
