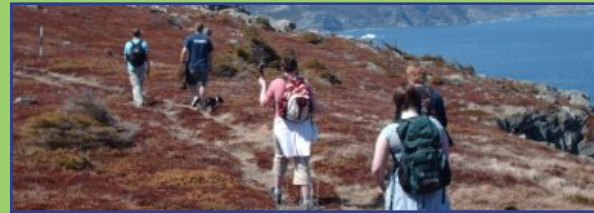
Distinguished Public Service Award
